SALES AGREEMENT SHOW/BREEDING PROSPECT

In regards to the sale of a red and white Welsh springer spaniel

This is a show/breeding prospect puppy being sold for the amount of \$2000 with the following guarantee. The seller agrees to refund full purchase price if:

1. the buyer is in any way not satisfied with this puppy and contacts seller within 72 hours of the buyer taking possession of said puppy.
2. any unsoundness is noted by a licensed veterinarian within 72 hours of the buyer taking possession of the puppy. Full refund will be made after the return of the puppy to the seller.

The seller agrees to replace the above puppy with a show/breeding prospect puppy within one year of the diagnosis (the buyer may keep the original puppy) should the above puppy be found to have any of the following conditions:

1. Hip dysplasia and/or elbow dysplasia as diagnosed by OFA by 26 months of age.
2. Diabetes Insipidus as diagnosed by a licensed veterinarian following appropriate tests.
3. Juvenile cataracts, PRA, or glaucoma as confirmed by an ACVO veterinary ophthalmologist.
4. Epilepsy as confirmed at a university veterinary school after ruling out poisoning, tumor or trauma and after the following minimum blood work: blood sugar for diabetes or hypoglycemia; T3, T4, TSH; liver function; heavy metals.

The seller is not legally or financially responsible for any veterinary costs in regards to hip dysplasia, epilepsy, eye anomalies or any other health problems which the above named dog may have or develop. Should this dog be bred prior to receiving all health clearances (OFA hips, elbows, and thyroid; and CERF for eyes), then the buyer is under no obligation to replace the above named puppy should it not pass its health clearances.

If a male, the buyer agrees to allow free stud service to any Welsh Springer Spaniel bitch owned or co-owned by Gary Riese, Susan Riese, or Meghen Riese Bassel. Gary Riese and/or Susan Riese and/or Meghen Riese Bassel assume any other financial expenses incurred in getting their bitch(s) bred.

Should the buyer need to place the above dog for any reason, the dog is to be returned to the seller. The seller will return to the buyer any monies from resale, less any costs accrued to the seller due to the dog's return.

Buyer agrees to maintain this dog in show condition which includes proper nutrition and weight, correct exercise, training and continuous socialization to a variety of people and places.

Buyer agrees to maintain regular contact (at least every six months) with the seller and include the following: health information, training progress, any questions or problems, and photos of the dog. Buyer agrees to complete at least one kindergarten puppy class or beginner obedience course with this puppy before the puppy's first birthday.

The buyer agrees to:

1. Have this puppy examined by a licensed veterinarian within 72 hours of the buyer taking possession of said puppy.
2. Vaccinate this puppy against distemper, hepatitis, Para influenza and parvovirus at 12 weeks and as recommended by a veterinarian thereafter.
3. Vaccinate this puppy against rabies by six months of age and as specified by a licensed veterinarian thereafter.
4. Maintain this puppy on heartworm preventive with an annual blood check for the presence of heartworms.
5. Check this puppy for the presence of intestinal parasites at first veterinary examination, six months, and at least yearly thereafter.
6. **X-ray hips and elbows and collect blood for thyroid panel for this puppy between 24-26 months of age and submit the x-rays and blood to OFA for evaluation.** The Buyer shall initial the OFA hip, elbow, and thyroid forms to allow all health results, both normal and abnormal, to be posted on the OFA website. **Note:** buyer may have preliminary hip or elbow or thyroid evaluations prior to this time, but the buyer is still responsible for have OFA certification on hips, elbows, and thyroid between 24-26 months. Buyer agrees to have eyes examined by an ACVO veterinary ophthalmologist between 12 and 26 months of age.
7. Have all family members read the book "How To Raise A Puppy You Can Live With". All family members must be TOTALLY FAMILIARIZED with the methods given in this book and agree to use them with this puppy.
8. Attending and completing group puppy training classes and/or one set of basic group obedience classes which utilizes motivational training methods (and not to participate in any training classes which promote/advocate hitting, jerking or yelling at the dog) prior to the above named dog attaining 8 months of age.

Buyer agrees to show this dog at AKC licensed/member dog shows where championship points are awarded a minimum of 10 times by this dog's third birthday. If not already a member of WSSCA, Inc., buyer agrees to join the Welsh Springer Spaniel Club of America within 6 months of acquiring this dog and to maintain WSSCA membership for as long as the buyer owns a Welsh springer spaniel.

Buyer agrees to care for this dog humanely (including adequate food, shelter, water, and veterinary care) and to license this dog in accordance with the laws in the jurisdiction in which the buyer resides. Buyer agrees to keep this dog as a house pet to be exercised in a fenced yard or on a leash

and not to be free to roam unattended. Seller is in no way legally or financially responsible for any damage or destruction to person and/or property caused by this dog.

IF/WHEN THE ABOVE NAMED DOG IS BRED:

The buyer agrees that all puppies produced from the breeding of this dog will be placed/sold with contracts. This dog shall not be bred more than 10 times without written permission from Meghen Bassel or Susan Riese. The contracts are to include the following minimum requirements:

- a. the statement from the bitch owner/breeder: "Should this puppy need to be re-housed for any reason, it is to be returned to the bitch owner/breeder."
- b. the puppy and owners will attend and complete puppy training or one set of basic obedience classes which utilize motivational training methods prior to 8 months of age.
- c. the puppy will receive all of its necessary vaccinations as indicated by a veterinarian (rabies shots must be administered by a licensed veterinarian).
- d. the puppy will have its hips and elbows x-rayed and blood drawn for a full thyroid panel and evaluated by OFA between 24-26 months of age. All test results (OFA hip, OFA elbow, and OFA thyroid) shall be made public on the OFA website, regardless of if they are normal or abnormal. All test results shall also be reported to the stud dog owner.
- e. the following statement: "Puppy buyer agrees to care for this dog humanely (including adequate food, shelter, water, and veterinary care) and to license this dog in accordance with the laws in the jurisdiction in which the buyer resides. Buyer agrees to keep this dog as a house pet to be exercised in a fenced yard or on a leash and not to be free to roam unattended."

The owner of the bitch/breeder agrees to provide adequate and proper stimulation and socialization and health/sanitary conditions for the puppies as directed in the book "How to Raise a Puppy You Can Live With". The owner of the bitch/breeder agrees to provide each puppy owner with a copy of the book, "How to Raise a Puppy You Can Live With" (Rutherford and Neil, ISBN #0-931866-57-X) prior to the new owners receiving the puppy. The new owners MUST read this book PRIOR to getting the puppy. The owner of the bitch/breeder agrees to send a list of names, addresses, and phone numbers of the owners of the puppies produced by this bitch to the seller. The owner of this bitch/breeder agrees to maintain regular contact with the puppy owners (at least every six months) and to relay any and all pertinent information regarding health, temperament, and training to the seller.

In the event of a dispute over the terms of this Agreement or the sale of the Puppy mentioned in the first paragraph above, Georgia will be the state having jurisdiction over the matter and Georgia law will control the resolution of any dispute.
